

## Brunswick Middle School PTO Musical Code of Conduct 2015

We ask that every family read through this Code of Conduct together, discuss it, and have each participant sign it, so that we can enjoy a safe, productive and **FUN** experience. We, the families participating in the BMS Musical, promise to uphold the following guidelines:

### As a Parent:

- I will reinforce that my student behave in a respectful and appropriate manner that will not harm others participating in and helping with the musical, including students, volunteers, staff and our director.
- I will be on time picking up my student at the end of audition/rehearsals.
- I will stress with my student that this is a serious commitment and see that he/she attends regularly.
- I will volunteer my time, in some way, to help make the production successful.
- **I understand that by giving my child permission to participate in the play that my child will be photographed and recorded by PTA Volunteers for a dvd that will be available for purchase. In addition, I understand video clips of the performance may or may not be posted to social media (including newspaper) sites, by audience members.**
- I understand that electronic devices (including phones) **are not permitted** during play practice and my student must put them away (which may be in his/her locker).
- I understand during Tech Week my student must be at practice Monday through Thursday and that the times of practice will be extended to 6:00 and I will pick my student up at BHS.

### As a Student:

- I will arrive on time ready to work on all practice days and make my commitment to the musical my priority.
- I will work hard at all times, rehearsing, running lines, reviewing songs/dances or completing homework.
- I understand during Tech Week I must be at practice Monday through Thursday and that the times of practice are likely to be extended
- I will follow all FCPS policies and behave in a manner that is respectful to all students and adults, their property and school property while participating in the musical. **This includes the following:**
- I will keep my phone/electronic devices put away (may be left in locker) during practice.
- I will use appropriate language.
- I will make sure an adult knows where I am at all times.
- I will clean up after myself.
- I will remain in the school building, until rehearsal is over.

Our goal is to ensure that every participant of the musical have a pleasurable experience. Therefore, there shall be consequences for anyone who is not allowing a pleasurable experience for all. A student will be allowed three warnings before we impose a consequence. With each warning, a student will receive a written notice, detailing where he/she deviated from the behavior contract he/she signed. **Once three warnings have been received, the student and family will be faced with a choice: give up participating in the musical, or have a parent/guardian attend all remaining rehearsals and performance to support/enforce appropriate student behavior.** As with all behavior contracts, we will be more successful during rehearsals if students know we have your undivided support regarding behavior expectations and consequences.
